Climate Ethics and Equity Forum Breakout Session Summaries

1. Green Jobs and a Vibrant Economy

Key Ethical Principles

- a) Justice good jobs and access to them
- b) Universality greatest good for the greatest number
- c) Empowerment through community organizing

Key Ethical Actions

- a) Build stronger relationships between labor, environment and faith ex. dialogue, joint camp, actions
- b) Reach out and empower individuals to be part of a network for change ex. neighbors, house parties with Weatherize for Good
- c) Engage to support big picture change ex. Influence Sen. Merkley, state letter to support cool schools

2. Profits, Debt and Climate

Key Ethical Actions

- a) Distribution of any aid or savings to NGOs
- b) Keep public records of how global south is spending aid or savings
- c) Have the progressive faith communities be more vocal and active in the political arena

Practical everyday steps

- a) Being informed consumers of products of foreign countries understand what the product has on its social structure
- b) Communicate the moral imperative of the global north to support debt relief and take action on climate change
- c) Get policy makers to communicate their stand on this

3. Biodiversity and Wildlife Habitat

Key Ethical Principles

- a) All species have value
- b) Preserve natural system stability
- c) Loss of biodiversity affects some people disproportionately
- d) Doing nothing is unethical
- e) Doing something can also be unethical e.g. forcing people to change their nature-based culture

4. Transportation Access and Climate

Observations/Important Info./Questions

- Transportation improvements will also result in better communities keep money in community
- How can we shift balance between cars and alternative transportation. Important to get public transit to low-income, both because of equity and climate
- Tri-met's legal monopoly limits choice
- Question to ask "what is the best way to provide transit?"
- Metro is actively engaged in transit planning
- One third of CO2 comes from transportation
- How can we talk about limiting choices without raising resistance?
- Can frame the question as a way to increase choice for all
- Need transportation that works for all
- Transportation vis a vis "food deserts"
- Transportation costs limit the ability of low-income folks to make other healthy choices
- Different communities may have different moral vocabularies

Key Ethical Principles

- a) Equity: Everyone deserves to have their needs met, benefits and burdens need to be shared, everyone deserves a voice
- b) "Just Faith" solidarity Stand by one another, people who are affected must have a voice
- c) Equal access to transportation "Fairness"

Key Ethical Actions

- d) Choice vs. equity "may have to limit choices"
- e) Gentrification needs addressing
- f) Affordable housing [is connected to transportation and needs to be addressed]
- g) May need to put more transit time in the day, make this a spiritual practice e.g. "walk to the bus"
- h) Unique opportunity for faith communities to push for/model better transportation models
- i) Metro listening to what motivates participants [please get involved and contract them]
- i) Make sure all "at the table" are heard

5. Indigenous Rights

Observations/Important Info./Questions

- Preservation and use of forests, water, resources
- Stewardship by Indigenous people (compensation)
- Indigenous people tied to land and experiencing effects of climate change now. ex. water, caribou, fish

- Changes in forestry and agriculture increase demand for water, more polluted water and less available for local people
- Diminished resources i.e. food
- Increased health effects.
- Lack of representation at US and global forums
- Mitigation strategies can result in displacement i.e. biofuels, dams

Key Ethical Actions

- a) Involvement/representation by indigenous people [in decisions and processes]
- b) Empowerment of women
- c) Listen to Indigenous people's solutions
- d) Create dialogue
- e) Educate people about their rights
- f) Eradication of debt
- g) Sponsor conference on Indigenous peoples and climate change
- h) Support organizations working to
 - o Empower women
 - o Eradicate debt
 - o Protect resources Indigenous people rely on
 - o Recognize and support rights of Indigenous people
- i) Renewable Energy Policies and Justice

Observations and Key Ethical Actions

a) Honest pricing, sustainable tax code, hopeful, protection/preserve, stability, BAU – extremists, relate to American core values, inclusive, moral movement – taking care of each other, shared language, positive stories, engaging narratives, need new business models, green as fundamental, makes economic sense –long-term/lifecycle thinking, take what you need – no more, all of us, into the future

- Transitions Abundance in the future

Key Actions

What creates change? (Notes from participants response to the question)

- Multiple entry points
- Million letter march May 22nd faith
- People who have time should take the time to lead
- Self-education
- Congregations can educate their own
- Create a vision keep it simple
- Include everyone
- Be ready for future because it will be different
- Create experimentation
- Do one small thing
- Courageous visionary leadership (providing for grassroots orgs/inst.)
- Transition Town movement a new vision and strategies to get there
- Hope
- Love
- Help people understand values and implications of those values
- Denial/addictions/isolation moving to community and connection
- People change when they see other people change not motivated by ethics and theology, but social strategies
