Public Input Opportunities

Generate the Future

Although information about the plans of coal companies is not readily available to the public, there are important public input opportunities coming up soon that would benefit from the voices of people of faith with a concern for the Common Good and the environment. Beyond these opportunities, the timeline for other public input is unclear. Call Oregon Interfaith Power & Light (OIPL) at (503) 221-1054, ext 214 or 210, for updates.

- 1. Unlike Oregon, Washington State's Dept. of Ecology requires Environmental Impact Statements (EIS) for many projects. In late summer, they will start a 60 to 90-day scoping process as part of the EIS process to determine what the EIS should cover. Since coal trains to serve Cherry Point near Bellingham would come through the Columbia Gorge and southwest Washington, Oregonians can comment. It is possible that a public input meeting will be held in Vancouver, Wash., in the early fall.
- 2. **Oregon's Department of State Lands** will be opening up a 30-day public comment period in late summer or early fall for the proposed Port of Morrow coal barge facility in the Boardman area. Go to http://cms.oregon.gov/dsl to register your comments when the public comment period opens.
- 3. The City Council of Portland will discuss their on their coal export resolution on Wednesday, September 19, at **2 p.m.**, and public comment is invited.
- 4. The City Council of Eugene, also on September 19, at noon, will hold a panel on their resolution to oppose coal trains and public comment is invited.
